Gifted testing. 10 students tested in!

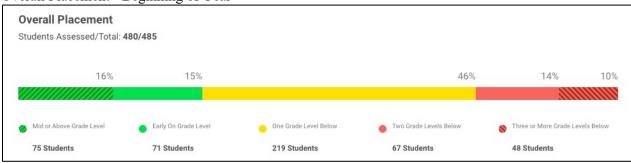
Special Education. 9 students found eligible with 2 needing speech only. 2 Speech-only evaluations are in process. 2 psychological evals are in process including 1 with OT.

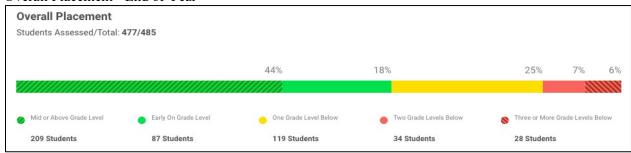
EIP. 6 students tested out!

Reading areas for improvement:

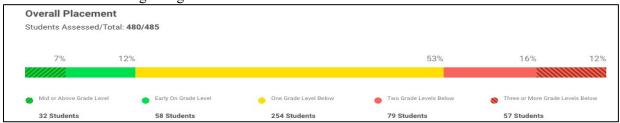
- Vocabulary

Highest performing grade levels in Reading: Kindergarten followed by 8th

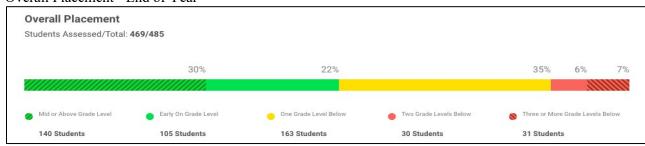
Lowest performing grade levels: 6th followed by 7th

 - More teachers used their checklists for getting through their standards. 2 years ago, unit plans were developed at BIA to make pacing guidance documents based off of the GA Standards of Excellence. Quarterly checklists were developed to help teachers stay on track and get through the standards.
 - Ms. Newman hopes to have more opportunity to check in with teachers next year to assist with pacing.
 - A goal, going forward, would be to utilize more pre-assessments to filter out things that the students already know and focus on content that they need to know.

Georgia Milestones Update. Georgia Milestones Predictor. Preliminary data is currently being imported into the assessment portal; nothing available at this time. GA will be using this 2021 - 2022 Milestones as a new baseline, post-pandemic.
